JUAB COUNTY JAIL VISITING INFORMATION

VISITING AREAS

The jail provides secure areas for inmate personal visitation. The visiting areas allow inmates and visitors to clearly see and hear each other through a security barrier. Contact visits are only allowed with some attorneys or in exigent circumstances and must have authorization from the Jail Commander. Contact visits generally aren't allowed.

VISITING SCHEDULE AND FREQUENCY OF VISITS

The jail will provide a visiting schedule which sets forth the days and hours of personal visitation. The visiting schedule will provide an opportunity for inmates to have visits at least one day each week. Visits may be limited to 20 minutes. Visitors traveling over 100 miles may be allowed a 2 hour visit. Inmates in disciplinary segregation will not receive personal visits. Inmates are responsible for notifying their family and friends of changes in their visiting status. It is the visitor's responsibility to show up early enough to receive the allotted time for the visit. No visits during any period of the jail being locked down. Visitation for Males is Wednesday from 7:00 P.M. – 9:00 P.M., Females are on Thursday from 7:00 P.M. – 9:00 P.M.

PRIVACY

Conversations in public and inmate visitation areas may be monitored. Inmates will be notified verbally or in writing that they have no expectation of privacy in personal visitation. Jail staff will oversee visitation and provide visual supervision and surveillance of visiting areas. Video Visitation is also recorded by the Video Visitation provider. A deputy will respond to any problems.

NUMBER OF VISITORS PER VISIT

A maximum of three people may visit an inmate at one time. Visitors may not switch places with other persons during the visitation period.

CHILD VISITORS

Children must be accompanied by a parent or legal guardian. Children must be controlled while visiting or the visit will be terminated. Children may not be left unattended in the public lobby or on jail grounds.

- **A.** Age for Approved Visitors: Children under the age of 18 may visit during any scheduled visiting time but must be accompanied by a parent or legal guardian.
- Minor children may only visit parents, grandparents, and siblings.
- **B. Unattended Children on Grounds:** Visitors are prohibited from leaving children unattended anywhere in the building or on the grounds of the security center. Visiting staff will not tend or monitor children left in the lobby area or grounds while a parent visits.
- **C. Married Minors:** If a visitor under the age of 18 is the spouse of an inmate, unaccompanied visits will be approved if the spouse can produce valid government or school issued photo identification and a marriage certificate.

VISITOR IDENTIFICATION AND REGISTRATION

Visitors must register upon entry into the facility. Visitors 16 years of age or older may be required to present current government or school issued identification which includes a photo and date of birth when registering to visit. All visitors will be logged into the computer prior to accessing the visiting area, if others are waiting in line they will have to wait for this to be finished.

CRIMINAL RECORDS CHECK OF VISITORS

All visitors are subject to a criminal record check before being admitted to a visiting area. If an outstanding warrant appears on the visitor's records check, dispatch will confirm the warrant and to request contact with the appropriate law enforcement agency. These visitors may be placed under arrest and booked into the jail.

VISITORS LEAVING ITEMS FOR INMATES

Visitors are not permitted to leave packages, letters, or other items for inmates.

VISITOR DRESS AND BEHAVIOR

A. Dress: All visitors must be fully clothed, including shoes (this does not apply to infants), shirts, pants, knee length shorts or dresses. Clothing that is see-through, short shorts, exposes the breasts, buttocks or genital area or is in any other way revealing, is prohibited. Clothing that incorporates lewd or obscene logos or images are also prohibited.

B. Behavior: Sexually provocative behavior during visits is prohibited. Visitors engaged in suggestive or lewd behavior, including disrobing, opening shirts, blouses or trousers, or any other type of indecent exposure or behavior will lose their visiting privileges.

C. Intoxication: Visitors who are obviously intoxicated will not be allowed to visit.

VISITOR PERSONAL PROPERTY

Visitors may not bring any personal, carried items, past the public lobby into the visiting areas.

VISITOR SEARCHES

Visitors may be required to submit to a rub search if there is reason to believe that they may be carrying any item which may threaten the safety and security of any person or of the facility. Visitors will not be required to submit to a strip search as a condition of visiting. If concerns regarding a visitor are so great that the staff believes they warrant a strip search, the visit will simply be denied and the visitor advised of the denial. This denial will be documented in the file of the inmate the person requested to visit.

DENYING OR TERMINATING VISITS

A. Visitation Refusal or Termination: Visits will be refused or terminated when:

- 1. The visitor is the victim of the crime the inmate for which the inmate is incarcerated;
- 2. The visitor has been incarcerated in the Juab County Jail within the past 45 days;
- 3. The inmate or visitor attempts to bring in or pass contraband;
- 4. The visitor is inciting violence or disorder;
- 5. The visitor has an outstanding warrant;

- 6. The visitor is wearing unacceptable attire, which may include but is not limited to no shoes (does not apply to infants), no shirt, clothing that incorporates lewd or obscene logos or images and clothing that exposes the breasts, buttocks, or genital area; or
- 7. The visitor is engaged in suggestive or lewd behavior, including disrobing, opening shirts, blouses or trousers, or any other type of indecent exposure or behavior;
- 8. The inmate's visiting privileges have been temporary restricted;
- 9. There is a court order prohibiting the visit;
- 10. A facility security or emergency situations exists;
- 11. The visitor is under the influence of alcohol or other intoxicant, stimulant, or depressant;
- 12. It is requested by the inmate;
- 13. The visitor has no identification or the identification is unacceptable;
- 14. The visitor's inability or refusal to control children is creating noise or behavioral disturbance that is interfering with other visits, the safety of the visitors or the orderly operation of the facility.
- 15. The inmate or visitor is creating noise or a behavioral disturbance.
- 16. The inmate has been convicted of a sex crime involving a minor; the inmate is prohibited from visiting anyone under the age of 18 years old.
- 17. The visitor is a former staff member (unless approved by the Jail Commander).
- **B.** Inmate Notification of a Refused Visitor: When a visit is refused by the facility, the inmate will be immediately advised by the housing deputy why the visit was refused.
- **C. Visitor Notification of Suspended Privileges:** Jail staff who has cause to request that a visitor's visiting privileges be temporarily suspended or revoked will write a report to their immediate supervisor detailing the justification. This report will be forwarded to the Jail Commander for his review. If he concurs with the action, the visitor will be notified in writing whenever possible, that his visitation privileges have been revoked or suspended and the reason for the action, and on what date visiting privileges will be restored.

NOTICE OF VISITING RULES

Rules and regulations governing jails visits should be posted in all housing areas and in the public lobby. Rules will be available in both English and Spanish.

VIOLATIONS OF VISITING RULES

The severity of the penalties for violating visiting rules will be commensurate with the seriousness of the violation of the rules.

A. Inmate Violations: Violations of visiting rules by inmates shall be processed through the inmate discipline procedures and may result in:

- 1. Warnings;
- 2. Disciplinary write-up
- 3. Suspension of visiting privileges; and/or
- 4. Criminal actions.

- **B. Visitor Violations:** Visitors who violate visiting rules are not entitled to a due process hearing. However, they may appeal actions taken against them to the Jail Commander. Violations of visiting rules by visitors may result in:
 - 1. Warnings;
 - 2. Suspension of visiting privileges;
 - 3. Permanent revocation of visiting privileges; and/or
 - 4. Criminal prosecution.

SPECIAL VISITS

- **A. Long Distance Travel:** Inmates anticipating a visitor who will be traveling more than 100 miles may request a visit outside of regularly scheduled visiting hours. This should be done in advance. Deputies who will be on duty during the approved visit will be notified. If a special visit is requested for distance visitors without advance notice, it may be approved at the discretion of the on-duty supervisor.
- **B. Delivery of Messages:** Special visits may be arranged for the delivery of death messages or other news of a highly serious and personal nature.

SECURITY

Locking Visiting Doors: When inmates are placed into visiting rooms the deputy running visiting will lock the door to the room the inmate is in.
